- Old Business/New Business
 - Operators Report: Carlos Vigil presented the operators report (December 2013 and January 2014); a copy is readily available in the EVWA office for review.
 - All topics and emergency calls were explained by Carlos and a extensive review of how Carlos will repair all emergencies were discussed

Budget Adjustment

- The "Less uncollected revenue" continues to be a problem for EVWA. Edward S. requested a total amount and accounting for all members was requested for the next meeting.
- A motion was made to send a letter to all members who owe money, with a guaranteed 20% down by the date of March 1st, 2014 and a signed contract.
- The budget should reflect the sections of "connections and overages" separate items. Less Uncollected Revenue will be a consistent topic for each monthly meeting. We have a goal of collecting 50% of the debt by year's end.
- Edward S made a motion to table the budget adjustment till the February meeting when we are able to look at multiple points of real time data from a two year period. As part of this budget a business plan will be made to set the course for the rest of the year.

o Agreed Upon Procedures 2011 Report

- A document by Accounting and Auditing Services, LLC was presented to the board. The document was an independent accountant's report on applying agreed-upon procedures.
- A motion was made to accept the Agreed upon Procedures report by Rick K, and, accepted by Edward S. All members are in agreement with no opposition

Loan Agreement-South San Ysidro and Ilfeld

- A document was created to protect our investments into South San Ysidro and Ilfeld till they merge fully with EVWA. The agreement and drawdown schedule were presented to the board
- Rick K made a motion to accept the agreement and drawdown schedule for the communities of South San Ysidro and Ilfeld. The

motion was second by Edward M; all members were in agreement with no opposition.

General Funding

- EVWA did not qualify for the Water Trust Board Funding.
- Legislative funding has been submitted.
- Edward S and Rick K made a motion to create a document to share with our communities that" we as an Alliance have professionals on our board that have a business conflict of interest in the contractual obligation" These members will excuse themselves during contractual voting when their companies are part of the bidding process.
